You then apply for the SMC-B from a trust service provider (VDA). The VDA charges an annual fee that varies from provider to provider.</p>

Verfahrensablauf	<p>You can renew SMC-B online as a nursing, obstetric or physiotherapy facility:</p> <ul style="list-style-type: none"> • Go to the specialist portal of the Electronic Health Professions Register (eGBR) and fill out the online application • Upon receipt of your application, it will be reviewed. • The examination costs an administrative fee. • After completing the check, you will receive an email with the result of the check and your transaction number. • With the transaction number, you can order an SMCB from a trust service provider (VDA) of your choice for a fee. • The VDA charges an annual fee that differs from vendor to vendor
