Teaser	If you would like to carry out a non-essential activity of a craft subject to licensing independently and have a relevant journeyman training, you must be registered in the register of your locally competent Chamber of Crafts.
Volltext	Chambers of crafts represent the interests of the entire craft sector in a chamber district. They have the task of promoting the companies of the region and supporting their interests through self-administration. If you independently carry out a non-essential activity of a craft subject to licensing, which quantitatively accounts for the majority of your commercial activity and is carried out in the form of a craft business, and if you have a journeyman training in a craft subject to licensing, the training contents of which have prepared you for the activity carried out, you are a compulsory member of the Chamber of Crafts. By taking up your commercial activity, you must apply for entry in the register of persons pursuant to § 90 paragraphs 3 and 4 HwO. The competent authority is the Chamber of Crafts in whose district your commercial establishment exists. As soon as you belong to the Chamber of Crafts, you

Erforderliche Unterlagen	 Copy of identity card or comparable identification document Copy of the business registration (can be submitted later after registration)
Voraussetzungen	 Self-employed exercise of a non-essential activity of a craft subject to licensing. In quantitative terms, this activity accounts for the majority of commercial activity and is carried out in the form of a craft business. The applicant has a journeyman's training in a craft subject to licensing, the contents of which have prepared them for the activity performed. Certain preparatory measures which essentially correspond to completed journeyman training are treated in the same way.
