Teaser	If you would like to carry out a non-essential activity of a craft subject to licensing independently and have a relevant journeyman training, you must be registered in the register of your locally competent Chamber of Crafts.
Volltext	<p>Chambers of crafts represent the interests of the entire craft sector in a chamber district. They have the task of promoting the companies of the region and supporting their interests through self-administration.</p> <p>If you independently carry out a non-essential activity of a craft subject to licensing, which quantitatively accounts for the majority of your commercial activity and is carried out in the form of a craft business, and if you have a journeyman training in a craft subject to licensing, the training contents of which have prepared you for the activity carried out, you are a compulsory member of the Chamber of Crafts.</p> <p>By taking up your commercial activity, you must apply for entry in the register of persons pursuant to § 90 paragraphs 3 and 4 HwO. The competent authority is the Chamber of Crafts in whose district your commercial establishment exists.</p> <p>As soon as you belong to the Chamber of Crafts, you</p>
