Teaser	If you, as an immigrant of German descent, would like to independently exercise a craft subject to licensing, then there are special regulations for the registration of your business in the register of craftsmen.
Volltext	 The Register of Craftsmen is a register in which all natural and legal persons, and partnerships with legal capacity who operate a craft subject to authorisation as a standing trade (not itinerant trade or market traffic). A complete list of crafts requiring approval can be found in Annex A to the Crafts Code (HwO). Furthermore, the management is entered in the register of craftsmen, which is responsible for the technical management of the craft business and who has the necessary professional qualification to practice the craft subject to licensing. Both the owners of craft businesses and salaried persons may be considered as plant managers. In the latter case, the application for registration shall be

	accompanied by a manager's declaration and supporting documents.
	In the case of immigrants of German descent (expellees or ethnic German repatriates), the certificate of competence required for the exercise of the managerial function can be provided on the basis of a comparison of the professional qualification acquired abroad with the domestic master craftsman's examination for the craft to be practised.

Voraussetzungen	They must have the status of expellees or ethnic German repatriates in accordance with §§ 1 et seq. of the Law on the Affairs of Expellees and Refugees (BVFG).
	The professional qualification obtained in the country of origin must be equivalent to the domestic master craftsman's examination for the craft subject to licensing.
