Teaser	If you, as an immigrant of German descent, would like to independently exercise a craft subject to licensing, then there are special regulations for the registration of your business in the register of craftsmen.
Volltext	<ul> <li>The Register of Craftsmen is a register in which all</li> <li>natural and</li> <li>legal persons, and</li> <li>partnerships with legal capacity</li> <li>who operate a craft subject to authorisation as a standing trade (not itinerant trade or market traffic).</li> <li>A complete list of crafts requiring approval can be found in Annex A to the Crafts Code (HwO).</li> <li>Furthermore, the management is entered in the register of craftsmen, which is responsible for the technical management of the craft business and who has the necessary professional qualification to practice the craft subject to licensing.</li> <li>Both the owners of craft businesses and salaried persons may be considered as plant managers. In the latter case, the application for registration shall be</li> </ul>

• Proof of farm manager activity (copy of employment contract)

Voraussetzungen	They must have the status of expellees or ethnic German repatriates in accordance with §§ 1 et seq. of the Law on the Affairs of Expellees and Refugees (BVFG).
	The professional qualification obtained in the country of origin must be equivalent to the domestic master craftsman's examination for the craft subject to licensing.

Kurztext	<ul> <li>Register of craftsmen Registration of expellees and ethnic German repatriates with a passed examination abroad equivalent to the master craftsman's examination</li> <li>Register of craftsmen as a register of all owners of a business of a craft subject to authorisation in the standing trade (not itinerant trade or market transactions), exercised by natural and legal persons as well as partnerships with legal capacity.</li> <li>Recording of the management of the respective company.</li> <li>In the case of immigrants of German descent (expellees or ethnic German repatriates), the certificate of competence required for the exercise of the managerial function can be provided on the basis of a comparison of the professional qualification acquired abroad with the domestic master craftsman's examination for the craft to be practised.</li> <li>There is a legal obligation to be entered in the register of craftsmen.</li> <li>Deadline: Immediately upon commencement of craft</li> </ul>
