Teaser	Do you want to drill holes or other earthworks that can influence the movements or the quality of the groundwater? Then you must notify the competent authority beforehand.
Volltext	If you want to carry out so-called earth outcrops, you must report this to the competent authority. Outcrops are boreholes or other earthworks that extend so deep into the ground that they can affect the movements or nature of groundwater. The notification is required for the following projects: • Old mining exploration or cavity exploration • Investigation of contaminated sites (except groundwater measuring points) • Well • Geochemical investigation • Geophysical survey • Geothermal outcrops (other) • Groundwater measuring point (except wells) • Engineering geological investigation or ground investigation • Mapping (except base drilling) • Raw Material Exploration Drilling • Other information purposes • Geothermal use with groundwater heat pumps Each well provides data for the assessment of the subsurface at the respective location. The display enables the competent authorities to get an impression of the drilling project and the material

	produced on site. The authorities can carry out supplementary measurements and ensure the quality of the drilling results. This prevents costly wrong decisions in underground spatial planning.

Kurztext	• Excavation Notification Acceptance of works with direct or indirect effects on groundwater • Drilling / earth outcrops that may affect the movements or condition of the groundwater must be indicated. • Work must be notified to the competent authority at least one month before it begins. • The construction project may be started after submission of the notification. • Competent authorities result from the location of the planned drilling points, usually the lower water authorities
