Teaser	Have you completed further training as a specialist veterinarian abroad? Then you can apply for recognition as a specialist veterinarian in Germany under certain conditions.
Volltext	The qualification as a specialist veterinarian must be recognised in Germany. This means that you need recognition if you want to use the title "specialist veterinarian" for your specialisation in the selected federal state.
	With your training as a specialist veterinarian, you have acquired a medical specialisation in addition to your qualification as a veterinarian abroad. To work as a veterinarian in Germany, you first need a license to practice medicine or a professional license. In order to be able to work as a specialist veterinarian in Germany, you must also apply for recognition of your further training as a specialist veterinarian. This allows you to use the title "specialist veterinarian" in your respective specialisation.
	Note: You may only use the designation for your specialization if there is a corresponding continuing education title in Germany.

	The permission will be granted by the competent State Chamber of Veterinarians after checking your documents and requirements.
Erforderliche Unterlagen	<ul> <li>CV in tabular form with information on completed further training and professional experience</li> <li>Proof of identity (identity card or passport)</li> <li>Proof of German license to practice medicine or professional license and proof of equivalent level of education</li> <li>Certificates of further training and certificates of professional practice</li> <li>Written declaration as to whether you have already submitted an application for recognition to another veterinary association</li> </ul>
	If your documents are not available in German, you must submit German translations of your documents. The translations must be made by translators who are publicly appointed or authorised.
Voraussetzungen	<ul> <li>You must already have a state professional license (approbation) as a veterinarian valid in Germany or a professional license.</li> <li>You must prove the equivalence of your professional qualification as a specialist veterinarian.</li> </ul>
Kosten	Quarter of an hour or part thereof: EUR 15.00
Verfahrensablauf	Before you submit the application, you must already have a license to practice veterinary medicine or a professional license in Germany.

professional qualification is equivalent. The professional qualification is equivalent if there are no significant differences between your foreign professional qualification and the German professional qualification.

• If your qualification as a specialist veterinarian is recognised, you can use the specialist title in Germany. You will receive a notification.

If significant differences are found, the equivalence of your specialist veterinary qualification will not be certified:

- You will receive a justification.
- You can take an adaptation period or an aptitude test to prove the lack of knowledge.
- If you successfully complete the adaptation period or the aptitude test, you will receive recognition. You may then use the title "specialist veterinarian" for your specialisation.

You can take legal action against the decision of the competent authority within a certain period of time (for example, file an objection). The decision will then be reviewed. Details can be found in the information on the right of appeal at the end of your decision. We recommend that you first talk to the competent authority before taking legal action against the decision.

Usually 3 months. You will receive the acknowledgement of receipt within one month of submitting the application. The competent authority will inform you if documents are missing. A decision on your application will be made no later than 3 months after receipt of your complete documents. The deadline may be extended.
