Teaser	If you belong to the group of other family members of a German and your stay in Germany is still necessary to avoid exceptional hardship, you can apply for an extension of your residence permit for family reunification.
Volltext	If you wish to continue to reside in Germany as a third-country national family member of a German in order to avoid exceptional hardship, you must apply for an extension of your residence permit in good time before the expiry of the validity of your residence permit.

Sachverhalt

For the extension of the residence permit, the same conditions must be met and the same documents must be submitted as when the residence permit was first issued

The residence permit is a temporary residence permit and is usually extended for at least one year.

Erforderliche Unterlagen

- Recognized and valid identity document (e.g. passport or passport substitute)
 - Up-to-date biometric photo in the passport (45 x 35 mm)
 - Proof of securing a livelihood (e.g. from one's own assets, payment of a security deposit into a blocked account, bank guarantee, declaration of commitment)
 - Proof of health insurance coverage (e.g. confirmation of health insurance coverage or insurance policy).
 - In the case of minors: consent of all persons with custody to the planned stay (declaration of consent); if the parents with custody are unable to submit the application jointly for their child, a written power of attorney from the absent parent is required; if custody is granted to only one parent, the signature of that parent is sufficient

The documents and information must always be submitted in German. In individual cases, the Foreigners' Registration Office may require less or more evidence.

If necessary, you must submit proof of the family relationship and a justification of the exceptional hardship case to the Foreigners' Registration Office again.

Voraussetzungen

In principle, the same conditions must be met for the extension of the residence permit as for the first issuance of the residence permit. That is:

- You are a citizen of a country outside the EU or the EEA.

- The person you are joining is a German citizen and usually resides in Germany.
- They still belong to the group of other family members of a German, i.e. they are neither his spouse nor a minor unmarried child. Other family members include, for example, adult unmarried children, siblings, parents, parents-in-law, grandparents, uncles, aunts, nephews, nieces, sisters-in-law, foster children. Fathers of biological German children who are not married to the mother also belong to the eligible group of persons.
- There is still a special case of hardship, for example because your German family member is dependent on your help due to illness, disability or need for care.
Please note : Unfavorable conditions in your home country do not constitute a case of hardship.
- Their reunification continues to serve to establish family cohabitation with the German (e.g. shared apartment). In the case of a spatial separation only due to work and training or a community of assistance or care due to accommodation in a nursing home, a family partnership can also be affirmed if you maintain regular contact with the German that goes beyond a mere visit.
- You can continue to secure your livelihood and health insurance coverage without using public services.
Please note : In the case of underage family members, this requirement does not have to be met.
- There is no interest in expulsion against you.
- Your stay does not endanger or impair the interests of the Federal Republic of Germany

Kosten

- 96.00 euros for a further stay of up to three months for adult applicants
- EUR 48.00 for a further stay of up to three months for underage applicants
- 93.00 euros for a further stay of more than three months for adult applicants
- EUR 46.50 for a further stay of more than three months for underage applicants

Additional fees may apply for the issuance of a new residence permit in the form of an electronic residence permit (eAT card), which can also be used as electronic proof of identity.

The timing and form of fee collection and payment vary depending on the authority.

In certain cases, fee reductions or exemptions may be considered (e.g. for persons entitled to asylum or recognised refugees). Lower fees may apply for Turkish nationals.

Verfahrensablauf

- Find out whether your Foreigners' Registration Office allows you to apply online or has a special application form.
 - If you have not yet reached the age of 18, you are not allowed to submit the application yourself, but need a representative (as a rule, the application is made by the parents with custody).
 - If the application is only possible in person, make an appointment at the Foreigners' Registration Office. In the case of an online application, the Foreigners' Registration Office will contact you after receipt of your application to make an appointment.
 - If you have not yet reached the age of 18, you must be accompanied by at least one representative during the personal interview. If the parents with custody are unable to appear in person, a written power of attorney must be provided for the application.
 - During the appointment, your identity and documents will be checked (please bring your documents, if possible in the original, with you to the appointment).
 - If your application is granted, your fingerprints will be taken in the form of a new electronic residence permit (eATKarte) for the production of the residence permit.
 - The Foreigners' Registration Office commissions the production of the eAT card from Bundesdruckerei. After completion, you will receive information and can pick up the eAT card from the responsible office. The eAT card must always be picked up in person.
 - If your application is rejected, you will receive a

	rejection notice.
Bearbeitungsdauer	(at span): approx. 6 weeks to 8 weeks Note for further information on processing time: The processing time may vary depending on the workload of the Foreigners' Registration Office. It takes about 4 to 6 weeks for Bundesdruckerei to produce the electronic residence permit.
Frist	Application deadline: 6 weeks to 8 weeks Note (for more information on the deadline): The extension of the residence permit must be applied for before the validity of the current residence permit ends. The application should be received by the Foreigners' Registration Office at least six to eight weeks before the expiry of the residence permit. Note (for more information on the deadline): In case of extension, the residence permit is issued for at least one year.

Hinweise	<ul style="list-style-type: none"> • In the case of the extension of the residence permit, the Foreigners' Registration Office may waive the existence of the requirements "securing livelihood" in the case of adult family members. <ul style="list-style-type: none"> • The residence permit entitles the holder to pursue gainful employment. • You are not entitled to an extension of your residence permit. The Foreigners' Registration Office has a discretion (a margin of appreciation) as to whether it will grant family reunification. • The procedure at the Foreigners' Registration Office is usually carried out in German. • All information provided to the Foreigners' Registration Office should be correct and complete to the best of our knowledge and belief so that the request can be processed without major delays. • Incorrect or incomplete information can slow down the procedure and be detrimental to the persons concerned. In the event of an emergency, incorrect or incomplete information that is not completed or corrected in time vis-à-vis the Foreigners' Registration

Office may result in the revocation of residence rights already granted, a fine, imprisonment of up to three years or expulsion from the federal territory.

- Due to the complexity of the right of residence, this description is for information purposes only and is not legally binding.

Rechtsbehelf

- Objection to the decision of the Foreigners' Registration Office within one month of notification
- Bringing an action before the court named in the notice of opposition if the objection is not upheld

Kurztext

- Residence permit for family reasons extension for other family reunification to a German
 - In principle, the same conditions must be met for the extension of the residence permit as for the first issuance of the residence permit.
 - Family members of Germans who can obtain a residence permit for "other family reunification" include all third-country nationals family members who are not spouses or minor unmarried children (e.g. adult unmarried children, siblings, parents, parents-in-law, grandparents, uncles, aunts, nephews, nieces, sisters-in-law, foster children). Fathers of biological German children who are not married to the mother also belong to the eligible group of persons.
 - The stay in Germany must continue to serve to establish and maintain family life (e.g. shared housing). A spatial separation only due to work and training or a support or care community due to accommodation in a nursing home is also permissible.
 - The issuance of the residence permit must serve to avoid exceptional hardship (for example, special care needs that can only be provided in Germany). For example, unfavorable educational, economic, social and other conditions in the home country do not justify a case of hardship.
 - Living expenses (including health insurance) must continue to be covered from one's own resources for the duration of the stay. Livelihood can also be secured by third parties. In the case of underage family members, this requirement does not have to be met.
 - If the applicant has not yet reached the age of 18, the persons entitled to custody must agree to stay in Germany.
