Teaser	If you process or process, store or trade wine or grape must on a commercial basis, you are obliged to report your wine and grape must stocks to the competent authority.
Volltext	If you process or process, store or trade wine or grape must on a commercial basis, you must declare your stocks from 31/07 of the respective year to the competent authority. Under certain conditions, the reporting obligation does not apply.
