Volltext	The renewed driver card is valid for five years. The start of validity is the date of personalization (production) by the Federal Motor Transport Authority (KBA). The card should be renewed at least 15 working days before it expires. If the driver card has already expired when the application is submitted, an initial order will be placed. The validity of the renewed driver card immediately follows the expiration date of the old card. The expired driver card must be carried for 28 days in addition to the new card.
