Volltext	If you want to practice falconry in Germany, you need a falconry license in your name. If your falconer's hunting license has been revoked, you can apply for it again after the specified period of ineligibility has expired.

Voraussetzungen	• at least 18 years old when issued • personal reliability • physical fitness • concluded hunting liability insurance • falconer hunting license already issued withdrawn • elapsed blocking period

If you submit the application in writing, fill it out and submit it by mail or in person to the competent authority. The application and the evidence to be submitted will be checked for completeness and correctness.
