Volltext	If you would like to practice falconry in Germany, but you are not yet 18 years of age, you can only be issued a youth falconry hunting license in your name If your annual hunting license has been revoked, you can reapply for it at the authority responsible for your place of residence after expiration of the stipulated ban period.

Frist	The annual hunting license for youth is valid for a maximum of two consecutive hunting years. The hunting year begins on 01.04. and ends on 31.03..

Hinweise	• The youth hunting license entitles you to hunt only in the company of a custodial person or a supervisor appointed in writing by the custodial person. The accompanying person must be experienced in hunting. • The youth hunting license does not entitle you to participate in social hunts.
