Teaser	If your youth falconry hunting license has been revoked by the issuing authority, you may reapply for it after the specified period of ineligibility has expired.
Volltext	If you would like to practice falconry in Germany, but you are not yet 18 years old, you can only be issued a youth falconry license in your name. If your day hunting license has been revoked, you can apply for a new one at the competent authority after the expiry of the specified ban period.

Frist	The day hunting license is valid for 14 consecutive days.

Hinweise	• The youth hunting license entitles you to hunt only in the company of a custodial person or a supervisor appointed in writing by the custodial person. The accompanying person must be experienced in hunting. • The youth hunting license does not entitle you to participate in social hunts.
