Teaser	Older children and adolescents in full-time care have special needs. This requires close and intensive counseling of those involved in the foster care relationship. The child care service supports and accompanies foster carers and children with comprehensive services.
Volltext	Foster families are entitled to support and advice, because their tasks and the demands placed on them differ significantly from those of a family without a youth welfare mandate. As private individuals, they provide a public service within the framework of educational assistance. They thus commit themselves to cooperation within the framework of assistance planning and the care agreement concluded between them and the foster child service. In order to successfully meet the requirements of a foster family in the long term, they need professional support from specialists with proven expertise in foster child care issues. Continuous specialist support and advice for foster relationships helps to stabilize them in the long term and is thus an important contribution to ensuring the best interests of the child.
