Handlungsgrundlage(n)	
Teaser	You have acquired a professional qualification as a paramedic abroad and would like to work in the profession permanently in Germany? Then you can have your foreign professional qualification officially recognized.
Volltext	You can have a degree as a paramedic from abroad officially recognized in Germany. The procedure for recognition is called: equivalence determination.
	Please note: Your degree must be state-recognized in the state of your training. Informal or non-formal qualifications cannot be officially recognized in Germany.
	You apply for recognition at the competent office in the federal state in which you would like to work. To do this, you must submit an application with all the necessary documents to the relevant state authority.
	When determining the equivalence, the competent authority compares your professional qualification from abroad with the professional qualification in the federal state. Important criteria for the comparison are the content and duration of the training.
	You will receive a decision on the result of the procedure. The notice states the existing and any missing professional qualifications.

	The competent office will acknowledge receipt of your application within one month. The competent office will inform you if further documents are required.
	If you have submitted all the required documents, you will receive a decision with the result after 4 months at the latest. In certain cases, the competent body may extend the procedure.

Kurztext	 * Foreign professional qualifications as a paramedic recognition * It is possible to have a foreign professional qualification as a paramedic officially recognized. * The procedure is called "equivalence determination". * Documents to be submitted: application form, curriculum vitae, proof of identity, proof of education, relevant work experience, other qualifications, information about an already submitted application for recognition, certificate of registration, proof of health suitability, proof of personal suitability. * Processing time: 4 months from receipt of all necessary documents. In certain cases, the competent body may extend the procedure.

Rechtsbehelf	You can take legal action (for example, file an appeal) against the decision of the responsible office within a certain period of time. The decision will then be reviewed. Details on this can be found in the appeal instructions at the end of your decision. You should first talk to the responsible office before taking legal action against the decision.
