Volltext	If you wish to employ a pregnant or breastfeeding woman between 8 p.m. and 10 p.m., you must obtain permission to do so. The authority responsible for occupational health and safety may refuse or temporarily prohibit you from employing the pregnant or breastfeeding woman during this period in order to ensure the protection of the health of the woman or her child. If the supervisory authority does not refuse or provisionally prohibit employment, you may employ the woman between 8 p.m. and 10 p.m.

Voraussetzungen	• You can only submit the application if you are an employer. • The pregnant or breastfeeding woman must expressly declare her willingness to do so • A medical certificate must not speak against working until 10 pm. • There is no irresponsible risk to the pregnant woman from working alone. • There is no irresponsible risk to the child from working alone. • The documented assessment of the working conditions proves that there are no other irresponsible hazards.
Kosten	The fees are charged on a time and material basis. Please enquire at the supervisory authority responsible for your federal state about the processing fees incurred. The exact costs will be determined following approval.
