| Volltext                   | <p>You can extend your class B driver's license under certain conditions.</p> <p>With the code number B96, you may drive class B motor vehicles with a trailer with a permissible total mass of more than 750 kilograms. The permissible total mass may exceed 3,500 kilograms, but may not exceed 4,250 kilograms.</p> <p>Key number B196 allows you to drive motorcycles (including those with sidecars) with a maximum engine capacity of 125 cm<sup>3</sup>. The engine power must not exceed 11 kW. The ratio of power to weight must not exceed 0.1 kW/kg.</p> <p>To drive the key numbers you must complete the driver training, which is specified in the Driving License Ordinance (FeV).</p> |

## Rechtsbehelf

### Kurztext

- Driving License Extension of Class B by Key Number 96 or 196
  - Minimum age: 18 years
  - in the case of "accompanied driving from 17": 17 years of age
  - Proof of driving training of at least 7 hours required
  - Extent of theoretical training: at least 2.5 hours
  - Extent of practical training: at least 3.5 hours
- Key number 96 entitles the holder to drive class B motor vehicles with a trailer with a maximum permissible mass of more than 750 kilograms. The maximum permissible mass of the vehicle combination may exceed 3,500 kilograms, but may not exceed 4,250 kilograms.
  - Minimum age: 25 years
  - At least five years of possession of the class B
  - Proof of 9 teaching units of 90 minutes each
  - Extent of theoretical training: 4 teaching units
  - Extent of practical training: 5 teaching units
- Key number 196 entitles the holder to drive a motorcycle with an engine capacity of up to 125 cm<sup>3</sup>. The engine power must not exceed 11 kW. The ratio of power to weight must not exceed 0.1 kW/kg.
