Volltext	If you would like to hunt in Germany but are not yet 18 years old, you can only be issued a youth falconry hunting license in your name. If your German annual falconry hunting license for foreign youngsters has been revoked, you can reapply to the authority that revoked your hunting license after the specified retention period has expired.

Voraussetzungen	• at least 16 and not yet 18 years old at the time of issue • personal reliability • physical fitness • completed hunting liability insurance • youth falconry license already issued has been revoked • consent of the legal guardian • Elapsed ban period

	If you submit the application in writing, complete it and submit it by post or in person to the competent authority. The application and the supporting documents to be provided will be checked for completeness and correctness. If you meet all the requirements, you will be issued with an Alien Youth Falconry Hunting License.

Frist	The annual hunting license is valid for a maximum of three consecutive hunting years. The hunting year begins on 01.04. and ends on 31.03..
