Volltext	If you would like to hunt in Germany but are not yet 18 years old, you can only be issued a youth falconry hunting license in your name. If you are already in possession of a day hunting license for foreign young falconers but its validity has expired, you can apply for an extension.

	If you submit the application in writing, complete it and submit it by post or in person to the competent authority. The application and the supporting documents to be provided will be checked for completeness and correctness. If you meet all the requirements, you will be issued with an Alien Youth Falconry Hunting License.
Bearbeitungsdauer	
Frist	The daily hunting license is valid for 14 consecutive days.
weiterführende Informationen	
Hinweise	The youth hunting license only entitles you to hunt when accompanied by a person with parental authority or a supervisor appointed in writing by the person with parental authority. The accompanying person must be experienced in hunting. The youth hunting license does not entitle you to participate in group hunts.
