Your claims will be determined ex officio on the basis of the documents. The authority will inform you of the result in the form of a decision, which is usually sent to you by letter. If entitlements to benefits have been determined, you will receive an approval notice. If no entitlements are determined, you will receive a rejection notice. However, you also have the option of submitting the application online. To do this, you must complete the online application and upload the necessary supporting documents. The eligible costs will be transferred to the account you have specified. |
| Bearbeitungsdauer | The prerequisite for processing is that all mandatory information has been provided. The processing time varies depending on the competent authority and the individual case. It is not possible to give an exact time and it depends on the complexity of the individual case. |
