| Erforderliche Unterlagen      | <p>You will need the following documents to process the application:</p> <ul style="list-style-type: none"> <li>• Proof of the state examination certificate, to confirm that the training period prescribed by the respective law has been completed and the state examination has been passed or the notification of the determination of equivalence of the foreign professional qualification</li> <li>• Criminal and professional law declaration</li> <li>• Proof of reliability; this is the confirmation that you have not been guilty of any behavior that would make you unreliable to practice the profession. This can be done by submitting an official certificate of good conduct for submission to the authorities, not older than 3 months at the time the permit is issued.</li> <li>• Medical certificate stating that you are not unfit to exercise the profession in terms of health</li> </ul> |
