| Voraussetzungen   | <ul style="list-style-type: none"> <li>• Applicant and deputy must be over 18 years of age</li> <li>• Reliability of both the applicant and the deputy The required reliability requires above all that the applicant and the deputy have no criminal record.</li> <li>• Personal suitability of the applicant and the deputy The required personal aptitude is not possessed by persons who, for example, have facts that justify the assumption that they are legally incompetent, addicted to alcohol or mentally ill.</li> <li>• Specialist knowledge of the deputy in the case of commercial arms trading If required, the deputy can obtain the necessary proof of specialist knowledge of the most important firearms and firearms regulations and of the type, construction and handling of common firearms and ammunition by taking an examination at the Chamber of Industry and Commerce. Specialist knowledge is deemed to be given if the deputy fulfills the requirements for the registration of a gunsmith's business in the register of craftsmen.</li> <li>• Proof of a need The need (a reasonable cause) may arise from a particularly recognizable personal or economic interest, for example as a gun manufacturer or gun dealer.</li> <li>• Commercial or economic enterprise</li> <li>• A permit is only granted if the manufacture or trade in weapons is carried out commercially or independently as part of a commercial enterprise.</li> </ul> |
