Teaser	The cessation of a genetic engineering facility must be notified to the competent authority without delay, stating the date of cessation.
Volltext	<p>As the operator of a genetic engineering facility, you must notify the competent authority of any significant changes. This also includes the cessation of operations. The competent authority must be notified immediately of the intention to cease operations.</p> <p>The notification must be accompanied by documentation on the planned measures for compliance. Accordingly, it must be ensured that there are no risks to legal interests even after the cessation.</p>

Kosten	An administrative fee must be paid in accordance with the state ordinance on administrative fees. The obligation to pay fees also includes the rejection of

Verfahrensablauf	As the operator, you must notify the competent authority of any changes regarding the operation of a genetic engineering facility or the genetic engineering work. The competent authority will check the notification and issue a fee notice if necessary.

Frist	The competent authority must be notified immediately of any changes in accordance with Section 21 GenTG.
