Volltext	<p>#### Exceptional authorisation to park for severely disabled people in accordance with section 46(1) of the Straßenverkehrs-Ordnung (StVO)</p> <p>Under certain conditions, severely disabled people are authorised to park in places where this is not normally permitted. Eligible persons can also use the parking concessions as a passenger - a separate driving licence is not required.</p> <p>Proof of authorisation is the parking permit in conjunction with the written exemption permit, which explains and limits the individual privileges.</p> <p>**Note:** The parking permit must be clearly visible behind the windscreen of the parked car and the exemption permit must always be carried.</p>

"Blue Parking Permit" (EU-Wide)

The "Besonderer Parkausweis für Schwerbehinderte mit außergewöhnlicher Gehbehinderung und Blinde" on a blue background is issued as a European parking permit. It entitles the holder to park in parking spaces for severely disabled persons (wheelchair symbol) in all EU member states and enables further concessions such as

- parking for up to three hours in restricted parking bans (signs 286, 290)
- parking in traffic-calmed areas under certain conditions
- parking in residents' car parks

"Orange Parking Permit" (Nationwide)

With the orange "Besonderer Parkausweis für besondere Gruppen schwerbehinderter Menschen", parking concessions such as the above examples also apply nationwide.

****Please note!**** This permit does not entitle the holder to park in parking spaces for severely disabled persons (wheelchair symbol).

The yellow parking permit (which must be applied for additionally) can be used to authorise parking in individual, precisely defined parking spaces for the severely disabled in Saxony.

"Yellow Parking Permit" (Only in Saxony)

In the Free State of Saxony, there is also the yellow parking permit, which can be issued to a group of people who have more than the orange parking permit. It is only valid in Saxony.

This parking permit also allows parking concessions like the orange parking permit. The Verkehrsbehörde can also authorise parking in individual, precisely defined parking spaces for the severely disabled in

Erforderliche Unterlagen	<ul style="list-style-type: none"> • Completed application form • Severely disabled person's pass or proof that the requirements are met • for the "blue parking permit": a photo (recent photo, without headgear, dimensions: 35 x 45 mm) • for authorised representatives: written power of attorney and identity card of the applicant (also as a certified copy)
Voraussetzungen	<p>#### Authorised Persons</p> <p>"Blue" parking permit</p> <ul style="list-style-type: none"> • Severely disabled people with an exceptional walking disability (sign aG) • Blind people (mark BI) • Severely disabled people with bilateral amelia or phocomelia or comparable functional impairments <p>"Orange" parking permit</p> <ul style="list-style-type: none"> • severely disabled people with the G and B marks and <ul style="list-style-type: none"> • a GdB of at least 70 solely for functional disorders of the lower limbs (and the lumbar spine, insofar as these affect the ability to walk) and • at the same time a GdB of at least 50 for functional disorders of the heart or respiratory organs • severely disabled people who suffer from Crohn's disease or ulcerative colitis if they have a GdB of at least 60 • severely disabled people with an artificial anus and artificial urinary diversion, if they have a GdB of at least 70 • Severely disabled people who, according to a medical assessment, are equivalent to the above-mentioned groups of people

	<p>"Yellow" parking permit</p> <ul style="list-style-type: none"> • Severely disabled people with the G mark who have at least a GdB of 70 solely as a result of functional disorders of the lower limbs and/or lumbar spine and at the same time a GdB of at least 50 as a result of functional disorders of the heart and/or lungs • Stoma patients with a double stoma (artificial bowel outlet and artificial urinary diversion) • Temporarily entitled persons who, due to an illness, an accident or after a serious operation, suffer temporarily but for a longer period of time from such severe functional disorders of the lower limbs and/or lumbar spine that they must be spared avoidable journeys
