To do so, log on to the application portal under "Login and registration ELAN-K2".</p> <p>For more information on the online procedure, click on "ELAN-K2" at the bottom left of the entry page.</p> <p>Note: You must apply separately for permission for each independent trading and brokerage business that falls under the above requirements.</p>
