Supervisors may be, for example • the managerial staff of an operating department • persons authorised to carry out blasting operations • Plant foremen and forewomen • the technical supervisory personnel in explosive ordnance disposal • the warehouse management • Persons transporting explosive substances #### Other responsibility Supervisors who carry out such activities in establishments that are under mining supervision must apply for the certificate of competence using the form provided for this purpose at the Sächsisches
