Volltext	#### Notification of the intended commencement of use of the building in accordance with Section 82 (2) of the Saxon Building Code (SächsBO) You must give at least two weeks' notice before commencing the use of a building. This does not apply if your building project is exempt from procedures. In the case of a residential building, for example, the commencement of use would be the same as moving into the house. Fireplaces may only be put into operation once the authorised district chimney sweep has certified the suitability and safe usability of the flue gas systems.
