Voraussetzungen	• Only cold and simply prepared hot dishes may be offered. This means dishes whose preparation does not require special skills and also little time and effort. • In addition to wine or cider, at least one non-alcoholic beverage must also be offered.

	Note: The obligation to notify does not exempt from compliance with other legal regulations. Other regulations, for example hygiene regulations and closing times, must be observed.

Verfahrensablauf	You can use the form from Amt24 for the notification (Forms & Online Services). Forms are also available from the competent office. With the notification you must inform the competent body: • the planned period of the wine tavern • the place and the location where the grapes used for the production of the wine come from, as well as the place where the grapes were pressed and the wine was vinified
