| Erforderliche Unterlagen | <ul style="list-style-type: none"> • Certificate of passing the tax advisor examination or aptitude test or exemption from the tax advisor examination (certified copy) • Certificate of good conduct (document type O) - for submission to the Chamber of Tax Consultants • Proof of sufficient professional liability insurance • for lawyers, auditors or certified accountants additionally: certificate from the professional organisation that there are no obstacles to appointment (certificate in accordance with § 34 paragraph 4 sentence 2 DVStB) |
| Voraussetzungen | <p>Prerequisites for being appointed as a tax advisor are in particular that</p> <ul style="list-style-type: none"> • You have passed the tax adviser examination or the qualifying examination or have been exempted from the tax adviser examination, • You live in a sound financial situation, • You have not lost the ability to hold public office as a result of a criminal conviction, • You are not engaged in any activity that is incompatible with the profession (for example, as an employee in another profession or as a tradesman), • You have been granted cover by a professional liability insurer (for salaried employees: Proof of inclusion in the employer's liability insurance). |

| Verfahrensablauf | <ul style="list-style-type: none"> • The application for appointment must be made using the officially prescribed form. • Submit the completed form and the application documents to the Chamber of Tax Advisors and transfer the fee for processing the application. • The Chamber of Tax Consultants checks whether you meet the requirements and decides on your application. • The appointment is made by handing over a certificate. |
