Voraussetzungen	You do not need any proof of qualification to be included in the "List of owners of a business in a craft that does not require a licence or a trade similar to a craft" - in contrast to a craft that is subject to registration in the register of craftsmen. Note: A list of professions that can be operated as trades not requiring a licence or trades similar to trades can be found in Annex B of the Crafts Code.
Kosten	variable (according to the fee schedule of the Chamber of Crafts)
Verfahrensablauf	You can apply for a licence to practise in person, in writing or online at your local Chamber of Crafts (HWK) or via the Single Point of Contact; depending on the service, you can download the application form from the Internet or use the online service (see -> Online application).
	You are well advised to contact the chamber before submitting your application.
	 If you submit the application in writing, you must enclose the documents to be submitted - depending on the chamber - as copies, certified copies or originals.
	Trade licence
	The Chamber of Crafts must issue a certificate (trade card) for the entry in the register of owners of a business of a craft not requiring a licence or a trade similar to a craft. You can later use the trade card to legitimise yourself as a registered business.
	Contact your Chamber of Crafts in good time to find out about the procedure and the documents to be submitted in your specific case (see also the information below).
