Volltext	Approval of private inspection bodies under the Foodstuffs Act (LSpG) and the Trademark Act (MarkenG) The activity as an inspection body under Regulation (EU) No. 1151/2012 of the European Parliament and of the Council of 21.11.2012 on quality schemes for agricultural products and foodstuffs requires approval. This must be applied for. After receipt of the application, the inspection bodies receive special documents to prove their qualification according to the regulation of the Saxon State Ministry for Energy, Climate Protection, Environment and Agriculture (SMEKUL) of November 27, 2000, which contains the requirements and the procedure for the approval of private inspection bodies according to the Food Specialities Act and the Trademark Act. The approved inspection bodies are published on the
