The following businesses must be registered:

- Hatcheries with a capacity of 1,000 hatching eggs or more
- Breeding and multiplication farms with 100 animals or more

Kosten	Procedural fee: EUR 56.00 to 167.00 (depending on expenses)
Verfahrensablauf	Apply in writing to the responsible department for registration of your hatchery; you can obtain the required form from this authority. • Submit the completed and signed application by post together with the required documents and evidence. • The competent authority will check your application and carry out an on-site inspection. • Upon registration, your company will be assigned an identification number. #### Notifying changes Inform the authority immediately if there are any changes to your business. The notification can be made informally in writing or by e-mail. **Note:** The identification number can be withdrawn from any business that does not comply with the provisions of the ordinance.
