Volltext	Small craft whose hull, excluding rudder and bowsprit, has a maximum length of less than 20 m and is equipped with a propulsion engine whose net power is equal to or more than 2.21 kW require an official or officially recognised licence plate. The issuing body must be informed immediately of any changes to a licence plate for a small vehicle that has already been issued. The licence plate must be presented for correction, in particular in the event of a change of ownership, change of residence, changes of a technical nature (e.g. change of engine), allocation of a new licence plate or deregistration.
