Single Point of Contact  For this procedure, you can use the service of the Single Point of Contact (Einheitlicher Ansprechpartner). They will guide you through the administrative procedure, take care of correspondence with all the offices responsible for your request and will be available to you as a competent advisor.

Voraussetzungen	The test facility must meet the following requirements:  • The trial facility is headquartered in Saxony. • A permanent experiment manager is employed who has completed a university or technical college degree in the field of agricultural, horticultural or forestry science or comparable sciences and has at least two years of professional experience in carrying out corresponding experiments. • A suitable deputy for the experimenter has been named. • A sufficient number of qualified employees are employed. • There are suitable options for carrying out the experiment properly: Sufficient number of rooms Laboratory and field equipment Sufficient experimental areas and if necessary, greenhouses and climate chambers must be available.  • The testing guidelines to be used are known to the staff and are available. • A list of ongoing and completed trials is maintained for approval purposes. • All recordings made during the experiment are kept.

Hinweise	The recognised testing facility shall be obliged to notify the competent authority immediately of any changes in the persons referred to in paragraph 3 sentence 2 numbers 1 and 2.
	The competent body may require a recognised testing facility to provide it with information on ongoing and planned trials, in particular on the plant protection product to be tested and the trial location.
