Volltext	<p>#### Authorisation to use the professional title in the name of a foreign company in accordance with Section 11 of the Saxon Engineering Act (SächsIngG)</p> <p>Under certain conditions, foreign companies may use the professional title "Consulting Engineer" or a similar professional title protected in Saxony in their name or in the name of their company.</p> <p>The prerequisite for a domestic company to use such a designation is, as a rule, the registration of the company in the register of companies of the Chamber of Engineers of Saxony or another federal state. Companies that have their registered office outside the Federal Republic of Germany cannot be entered in the register of companies of the Chamber of Engineers of Saxony.</p> <p>Under certain conditions, you are also entitled to use the aforementioned professional title. To do so, however, you must notify the Saxony Chamber of Engineers of your service activity. The Saxony Chamber of Engineers will then check whether the legally stipulated requirements for using the professional title</p>

are met. If this is the case, the company is listed in a special register.

The notification is not necessary if the foreign company is already entitled to use the professional title on the basis of the law of another federal state.

The company does not become a compulsory member of the Chamber of Engineers of Saxony. Professional duties apply.

Single point of contact (EA)

For this notification procedure, you can make use of the service of the single point of contact. This person accompanies you through the procedure, takes over the correspondence with all offices responsible for your concern and is available to you as a competent advisor. Excluded from this are procedures relating to tax law.

Erforderliche Unterlagen

- informal written notification of the first provision of a service

Upon request of the Saxony Chamber of Engineers additionally:

- Proof that the company or its partners and legal representatives are legally exercising the activity in question according to the law of the company's country of origin
- Proof that the company fulfils the requirements to bear the professional title in its name
- Proof of the registered office outside the Federal Republic of Germany (single copy)
- Memorandum or Articles of Association (single copy)
- Proof of liability insurance (single copy)

Voraussetzungen

You may use the above professional titles in the name of the company if, among other things, the following requirements are met:

- Registered office of the company outside the Federal

Republic of Germany

- Authorisation under the law of the country of origin to use the professional title of Consulting Engineer or a comparable professional title in the name of the company
- sufficient liability insurance
- Regulation according to the articles of association or the statutes that the company is formed and represented by a majority of consulting engineers or jointly with persons who are entitled to use the professional title "architect", "interior architect", "landscape architect" or "urban planner"
- The notification of the first provision of services has been submitted to the Saxony Chamber of Engineers

****Notice:****

- Companies that do not have their registered office, head office or principal place of business in an EU member state or a state equivalent to this may be prohibited from using the professional title if reciprocity of recognition is not guaranteed.
- The Saxon Engineering Act contains detailed regulations on the above-mentioned requirements (see legal basis).

Kosten

Fee (one-time) for notification

- GmbH, partnerships under the Partnership Company Act and other companies: EUR 320.00
- Partnerships under the Partnership Act with limited professional liability: EUR 600.00

Verfahrensablauf

Before you provide services in the Free State of Saxony for the first time, notify the Chamber of Engineers of Saxony. Upon receipt of the notification, you have the right to use the professional title in the name of the company for an unlimited period of time.

- Inform the Saxony Chamber of Engineers that you intend to provide services for the first time; enclose the required documents with your informal letter.
- The Chamber of Engineers will immediately confirm

	<p>receipt of the documents and inform you of any missing documents.</p> <ul style="list-style-type: none"> • Provided you meet the requirements, you will receive a certificate of authorisation to use the professional title. <p>Under certain conditions, the Saxony Chamber of Engineers may prohibit companies from using the professional title.</p>
