Volltext	A work opportunity is an integration benefit for selected employable persons entitled to benefits (eLb), in which the participants perform additional, non-competitive activities that are in the public interest. The individual assignment period of the unemployed is generally limited to a total of 24 months within five years. Since 1 August 2016, participation can be extended once for a further twelve months. In any case, the eligibility requirements are checked again; automatic extension of the assignment is excluded.
Erforderliche Unterlagen	As a rule, no further documents are required. The Job Centre has information and proof of the participants' qualifications. Should the Job Centre nevertheless require further documents, the participants are obliged to submit them.
Voraussetzungen	<ul> <li>Funding is provided for employable persons entitled to benefits as defined in §7 SGB II who require special support and assistance.</li> <li>The work must be additional, non-competitive and in the public interest.</li> <li>A work opportunity can only be considered if integration into the labour market cannot be achieved with other benefits.</li> </ul>

Verfahrensablauf	<ul> <li>The responsible job centre selects the participant and concludes an integration agreement with him or her.</li> <li>The agreement specifies the necessary measures and services to help with reintegration into work.</li> <li>In addition to unemployment benefit II, you will receive additional compensation.</li> <li>You are covered by accident insurance through your sponsor.</li> <li>If you receive additional cash benefits from the measure provider, these are treated as income and offset against unemployment benefit II.</li> </ul>
