Erforderliche Unterlagen	It is advisable to enclose documents with the complaint that make it easier for the data protection supervisory authority to investigate or provide evidence of the alleged breach of data protection.
Voraussetzungen	You feel that your fundamental right to informational self-determination has been violated.

Verfahrensablauf	• Submit your complaint in writing, verbally, by telephone or electronically to the responsible data protection officer. • Describe the facts of the case in your complaint. • Name the allegedly responsible body. • The data protection supervisory authority will investigate your complaint, clarify the facts of the case and, if necessary, object to any breaches of data protection law. • You will be informed of the result of the review.
