Activities involving materials containing asbestos must also be notified to the competent authority before work begins.</p> <p>In principle, the manufacture, use and processing of hazardous materials containing asbestos is prohibited for both companies and private individuals. Exceptions apply to activities involving materials containing asbestos during demolition, renovation and maintenance work.</p> |
