| Verfahrensablauf  | <p>In the Free State of Saxony, you can take the examination of expertise at the Saxony State Directorate.</p> <ul style="list-style-type: none"> <li>• Please only use the form provided for your application.</li> <li>• Enter the desired examination date and tick the type of examination.</li> <li>• Send the signed application form by post or e-mail(Arbeitsschutz@lds.sachsen.de) to the relevant office.</li> <li>• You will promptly receive an invitation to the examination or, if the maximum number of participants is exceeded, an offer of an alternative date.</li> <li>• Please bring an official identification document (identity card or passport) with you on the day of the examination.</li> </ul> <p>Expertise test</p> <p>The examination covers general knowledge of the essential properties of the substances and mixtures listed in Annex 2 of the Ordinance, the hazards associated with their use and knowledge of the relevant legal provisions.</p> <p>The examination of expertise is based on the "Bekanntmachungen - Hinweise und Empfehlungen zum Sachkundenachweis gemäß § 11 der ChemVerbotsV" of the Federal Ministry for the Environment, Nature Conservation and Nuclear Safety.</p> <p>Depending on the type of expertise, the examination contains 30 to 60 questions, each with 4 possible answers (multiple-choice procedure). After passing the exam, you will receive a certificate.</p> |
