Joint register portal of the Länder

Since the concentration of the register of associations on the local courts of Chemnitz, Dresden and Leipzig on 01.11.2010, the register of associations in Saxony has been kept electronically. Online inspection of the electronically kept registers is possible via the register portal of the Länder. Data from the following public registers are available on the joint internet portal of the German register courts:

Erforderliche Unterlagen

Documents do not have to be submitted for inspection.

Voraussetzungen

There are no special requirements to be met in order to inspect the data. Data may only be used for information purposes.

Kosten

- Inspection of the register of associations (online and at the registry court): none
- Retrieval of data on the internet: none

- Printout or uncertified copy: EUR 10.00
- official printout or certified copy: EUR 20.00

Electronic transmission instead of printout

Verfahrensablauf

Anyone may inspect the register of associations without further ado. Electronic access is provided nationwide via the joint register portal of the Länder.

- You have the possibility to search specifically for registered associations by entering keywords.
- As a result of the search, various documents are regularly offered.
- From 01.08.2022, all documents available online will be available for retrieval free of charge.
