If your building project is to be constructed in an area without a B-Plan, but within a coherently built-up district, your building project must fit in with the character of the immediate surroundings and the development must be secured. If your building project is to be realised in an external area according to building planning law, development is generally out of the question.</p>
Erforderliche Unterlagen	If you are requesting information on a specific plot of land, you should bring information on the corresponding plot of land (e.g. district, parcel and plot number).
Voraussetzungen	Anyone may inspect the development plan. Upon request, the city or municipality must provide information on the contents.
