You must apply for this confirmation and prove your suitability. Expert bodies test and confirm the suitability of the designs of heat cost allocators for recording the proportional heat consumption. The distributors may only be used if they comply with the recognized rules of technology or their suitability has been proven in some other way. They will guide you through the administrative procedure, take care of correspondence with all the offices responsible for your request and will be available to you as a competent advisor.

Inquire directly with the competent body in this regard.
Voraussetzungen	The expert body must have: • the necessary equipment for testing and assessing heat cost allocators and • appropriately qualified personnel The metrological equipment of the expert body for heat cost allocators must meet the requirements of the Physikalisch-Technische Bundesanstalt. The competent body may require additional equipment.

In cooperation with the Physikalisch-Technische Bundesanstalt (PTB), the PTB will check your suitability and, if necessary, issue a certificate of proven suitability.
