Please Note: This report does not replace the trade permit of the trade supervisory authority for the placing on the market of toxic and very toxic plant protection products or of substances which are marked with the hazard symbols T (toxic) or T+ (very toxic) according to the Hazardous Substances Ordinance. The competent authority must also be notified immediately of any changes to the indicated ratios. Note: If you apply plant protection products for others or wish to advise others on the use of plant protection products, you must also report this. They will guide you through the administrative procedure, take care of correspondence with all the
