Voraussetzungen	<ul style="list-style-type: none"> <li>• The daycare centre provider decides on admission</li> <li>• physical and mental health</li> <li>• in some local authorities, proof that both parents are employed, in training or that there is a special need for help in the family is required for a full-day childcare place</li> </ul>
Kosten	<ul style="list-style-type: none"> <li>• Parental contribution in Saxony: maximum 30 per cent of staff and material costs.</li> <li>• The exact amount is determined by the municipal or city council.</li> </ul>
Verfahrensablauf	<ul style="list-style-type: none"> <li>• Look for a suitable kindergarten.</li> <li>• Enquire about the registration formalities directly with the independent organisation or the operator of the kindergarten.</li> </ul>

Frist	<ul style="list-style-type: none"> <li>• Regardless of the provider: Registration usually six months before the desired start of childcare.</li> <li>• Short-term enrolment is possible if a place is available.</li> </ul>
