<b>Verfahrensablauf</b>	<p>Submit your objection (local elections: request for correction) informally in writing to the city or municipal administration or explain it there in person for the record.</p> <p>Your letter should contain at least</p> <ul style="list-style-type: none"> <li>• the reason for your objection/application for rectification (with supporting documents if necessary)</li> <li>• Your first and last names</li> <li>• Your date of birth</li> <li>• Your residential address</li> <li>• Your signature</li> </ul> <p>The city or municipal administration will inform you immediately whether the correction will be made.</p>
