Sachverhalt

- Proof that the reasons for the revocation of the appointment no longer exist
- provisional confirmation of cover for the application to take out professional liability insurance in accordance with § 67 of the German Tax Consultancy Act (StBerG)

Voraussetzungen

In addition to passing the tax advisor examination or aptitude test (or exemption from the tax advisor examination), your personal aptitude determines whether you will be reappointed for the job.

The Chamber of Tax Advisors to which you belonged at the time your appointment expired or was revoked is also involved in the reappointment procedure.

You can be reappointed as a tax consultant if

- the appointment has lapsed through renunciation vis-à-vis the competent chamber of tax advisors,
- a legally valid disqualification from the profession has been lifted by pardon or at least eight years have elapsed since the legally valid disqualification, or
- the appointment has been revoked and the reasons which were decisive for the revocation no longer exist.

Kosten

Procedure: EUR 180.00

Verfahrensablauf

- Submit your application in writing on the officially prescribed form.
- Submit the application, including the required supporting documents, to the Chamber of Tax Advisors and transfer the fee for processing the application.
- The Chamber of Tax Consultants checks whether you meet the requirements and decides on your application.
- The appointment is made by issuing a certificate.

If you have any questions or need help with the application, the staff of the Chamber of Tax Consultants of the Freistaat Sachsen will provide you with more detailed information.

When you are appointed, you also become a compulsory member of the Chamber of Tax
