The application should not be older than three months. Equivalent documents from member states of the European Union and from other signatory states of the Agreement on the European Economic Area and from Switzerland will also be accepted.</li> <li>Information about other branches</li> <li>information on any participation in a company whose purpose is the planning or execution of construction projects</li> <li>proof of fulfillment of the special requirements for recognition in the respective fields and, if provided, specializations.</li> </ul> |
| Voraussetzungen          | You can work as an inspection expert if you:<br>• your personality is such that you can be relied upon<br>to perform your duties properly,<br>• have the ability to hold public office,<br>• work independently and on your own responsibility<br>• have your place of business in the Free State of<br>Saxony,<br>• have a command of written and spoken German.  |
