	Single Point of Contact
	For this procedure, you can use the service of the Single Point of Contact (Einheitlicher Ansprechpartner). They will guide you through the administrative procedure, take care of correspondence with all the offices responsible for your request and will be available to you as a competent advisor.

- Please complete the form and submit it to the regional office together with the required documents.
- If nothing stands in the way of the appointment, you will be given an appointment for the swearing-in ceremony. After the swearing-in ceremony, you will receive a certificate of approval.

Note: As a certified public accountant, you will be entered in the professional register of the Chamber of Public Accountants. As a certified public accountant, you may not be an employee of accounting firms, tax consulting firms or law firms, but only their legal representative.

As a national of another EU member state, you must prove that you are authorized to conduct statutory audits of annual financial statements and provide confirmation that you have passed the aptitude test. You must pass the qualifying examination before the examination board.
