The competent authority must also be informed immediately of any changes to the notified circumstances. Note: If you trade in plant protection products or wish to advise others on the use of plant protection products in the context of commercial activities, you must also notify us of this. Single Point of Contact (Einheitlicher Ansprechpartner) You can use the service of the Single Point of Contact for this procedure. They will guide you through the procedure, take care of correspondence with all the authorities responsible for your concerns and provide you with expert advice.
