- the birth certificate, in the case of married persons or registered partners also the marriage / civil partnership certificate
- proof of higher education entrance qualification (university entrance qualification); in the case of certificates obtained at foreign educational institutions, also the recognition notice from the competent authority
- proof of clinical traineeship or, in the case of pharmacist assistants, pharmacy engineers, pharmaceutical-technical assistants and pharmacy assistants, the corresponding certificates
- proof of having studied pharmacy for two years
- certificates of participation in the courses of study

Further documents are mentioned in the respective application forms.

Voraussetzungen

First section

- Pharmacy studies of at least two years
- Clinical traineeship of eight weeks
- Regular and successful participation in the courses in the subject areas listed in Annex 1 to the AAppO letters A to D

Second section

- Successful completion of the first section of the pharmaceutical examination
- Study of pharmacy for at least four years
- Regular and successful participation in the courses in the subject areas listed in Annex 1 to the AAppO letters E to I as well as an elective subject

Third section

- Successful completion of the second section of the pharmaceutical examination
